Metabolics and Ketogenic Product Update - Stock Situation Week Commencing 16th March 2026

Dear Healthcare Professional,

Please see the latest list of Nutricia products that are either out of stock or are in short supply. This may therefore influence deliveries via Nutricia Homeward or to Hospitals via our wholesale chain. We apologise for any additional work this may be causing you and your teams, but we are working hard to resolve this situation. Our primary focus is ensuring patients get the protein substitutes they require.

Please note: where a product is stated to be out of stock, **patients may not be affected if they are holding stock at home.** If any action is required for a specific patient, the Nutricia Homeward team will contact you and **therefore proactive changes to regimens are not required.** To manage supply, we might deliver smaller quantities more frequently to patients. If a patient is concerned, please ask them to contact Nutricia Homeward directly.

Key:

Red – Out of Stock product – Our Homeward team will contact the managing Dietitian if action is required to change to an alternative. The date identifies when we anticipate the product is available via Homeward or will become available via our wholesalers for supply to hospital or community pharmacies.

Orange – The product has **low levels of stock**; orders can be fulfilled but if from Homeward, may arrive in split deliveries; the date is when we anticipate additional stocks will become available.

Green - Sufficient stock is available.
