

This information is intended for Healthcare Professionals (HCPs) Only Product Update – Tube Feeding Stock Situation Week Commencing 11th August 2025

Dear Healthcare Professional,

Please see the latest list of Nutricia Tube Feeding products and the projected availability for the next four weeks. This may therefore influence deliveries via Nutricia Homeward or to Hospitals via our wholesale chain.

We apologise for any additional work that the stock constraints may be causing you and your teams, but we are working hard to resolve this situation. Our primary focus is ensuring patients get the feed they require to reduce undue pressure on the healthcare system.

Please note: Where a product is stated to be out of stock for Homeward, patients may not be affected if they are holding stock at home. If any action is required for a specific patient, the Nutricia Homeward team will contact you and therefore proactive changes to regimens are not required.

In order to manage supply, we might deliver smaller quantities more frequently to patients. If a patient is concerned, please ask them to contact Nutricia Homeward directly. Where products are no longer listed below, please consider these to be back in stock and with sufficient supply.

From week to week, you may see the short-term outlook change. This can be a result of various changes in the supply chain such as earlier/later quality control releases, transit times, factory production outputs or changes in demand.

Red Out of Stock product – Our Homeward team will contact the managing Dietitian if action is required to change to an alternative. The colour identifies when we anticipate the product is available via Homeward or will become available via our wholesalers for supply to hospital or community pharmacies.

Orange The product has low levels of stock; orders can be fulfilled but if from Homeward may arrive in split/half deliveries. Some Wholesaler depots may have low levels of stock.

Green Sufficient stock is available

Full recovery date: We anticipate sufficient and consistent availability of stock for all channels from this date onwards including safety stock. Full recovery dates are calculated on the basis that demand is stable and in line with forecasts.

Update on Ancillary Product Supply and Mitigation Measures, July 2025

Nutricia is committed to minimising disruption to NHS Trusts and patients. Ancillary products, which we source from multiple suppliers across the UK and globally, are currently exposed to broader supply chain challenges (e.g. instability affecting some supplier logistics routes, China port congestion, operational changes)

To proactively manage these risks, we have implemented a robust risk radar and mitigation strategy, which includes:

- Sourcing from multiple suppliers to reduce dependency
- Increasing inventory levels of key ancillary items and alternatives
- Expediting transportation routes
- With the introduction of the MyConneX patient app, we'll be encouraging patients to regularly check their stock levels and take a more active role in managing their supplies
- Ongoing engagement with the National Supply Disruption Response (NSDR) team at DHSC

To support transparency and planning, Nutricia will now include the top ancillary items in our new weekly stock letter format and detail where any alternative product use required.

Sustainability and Responsible Use of Ancillaries

We encourage all healthcare professionals to support efforts to reduce unnecessary usage and environmental impact by:

- Promoting the multiple use of giving sets and adaptors where feasible (e.g. one per day rather than one per feed)
- Avoiding single-use plastics where clinically appropriate
- Reviewing patient regimens to ensure appropriate quantities and types of ancillary products are prescribed
- Promptly notifying Nutricia Customer Services when patients come off the Homeward service

These actions not only help safeguard supply continuity but also contribute to environmental sustainability and improve storage and delivery efficiency for patients at home. We appreciate your continued partnership and commitment to patient care.



Ordering Fresenius Kabi Tube Adult Tube feeds for Hospital use via AAH

Following the recent communication dated 2nd May 2025 regarding the supply challenge for Nutrison tube feeds, we now have a simpler way to order Fresenius Kabi tube feeds for hospital use through AAH. This solution will be in place throughout the duration of the supply disruptions which are anticipated to resolve late August, early September.

The Fresenius Kabi tube feeds below, will be available to order through **AAH Tamworth**, week beginning 26th May at your usual Nutricia contract price. Please note: we are unable to make this stock available at local branches.
